# H.E. Natalia Royo De Hagerman AMBASSADOR OF THE REPUBLIC OF PANAMA TO THE UNITED KINGDOM OF GREAT BRITAIN & NORTHERN IRELAND

Natalia Royo studied journalism at the New York University (NYU) in the United States and has a master's degree in International Relations from the School of International and Public Affairs (SIPA) at Columbia University, a master's degree in Political Communications and a second master's degree in International Affairs from Fundación Ortega y Gasset/Universidad Complutense in Madrid, Spain.

Ambassador Royo held several positions in the Panamanian foreign service. She was Counsellor at the Mission of Panama to the United Nations, she was the coordinator for the Rio Group, and was in charge of conciliating the group's

positions before the United Nations and presenting them to the various commissions. Ambassador Royo continued her diplomatic career at the Mission of Panama to the Organisation of American States (OAS) during the XXVI General Assembly, hosted by Panama in June 1996. She also worked with the Permanent Mission of Panama to the United Nations Educational, Scientific and Cultural Organisation (UNESCO) and at the Ibero-American General Secretariat (SEGIB) in the capacity of counsellor for planning cooperation.

Ambassador Royo was also the Communications Director at the CODESPA Foundation on development in Latin America. Most recently, Natalia Royo was the Minister Counsellor at the Embassy of Panama in Spain, overseeing political and economic affairs.
